


Maria's World Foundation

The mission of Maria's World Foundation is to improve the quality of life of people with intellectual disabilities and the life of their families and help them achieve their full potential as individuals by providing access to high-quality services, developmental training and possibilities for gainful employment that are suited to their needs.

Since July 2013 the Worlds Day Care Centre has enabled 30 young people with intellectual difficulties to acquire work and life skills in order to improve their personal independence and quality of life.

Created in 2013 by a French Parisian couple passionate about art and culture, the Loo & Lou Foundation, under the aegis of Foundation de Luxembourg supports art creation and contemporary art in Luxembourg and elsewhere in Europe.

The Loo & Lou Foundation's latest project support includes the venue of the world-renown Korean artist Kim Jungman at the Musée Cernuschi in Paris during the *Nuit Blanche 2015*. The Loo & Lou Foundation also formed close ties with the Museum of Modern Art of Luxembourg, the MUDAM that welcomes for its 10 year-anniversary, the famous Belgium artist Wim Delvoye. An exceptional exhibition that started on July 2, 2016 with the support of the Loo & Lou Foundation.

FONDO AMBIENTALE ITALIANO

FAI is a national, not-for-profit trust that was set up in 1975 and has since gone on to save, restore and open to the public numerous fine examples of Italy's artistic and natural heritage. It has drawn inspiration from the National Trust for England, Wales & Northern Ireland, and is affiliated with INTO – the International National Trusts Organisation. It really does seem like yesterday when, way back in 1976, FAI received its first donation, from lawyer Piero di Blasi: a thousand square metres in Panarea, in the Aeolian archipelago. Fast-forward thirty-plus years to its latest acquisitions: the Woodland of San Francesco in Assisi, the Olivetti Showroom in Piazza San Marco in Venice and Villa Fogazzaro Roi in Oria di Valsolda (in the province of Como). In the intervening years, FAI has acquired assets very frequently, so much so that today it controls 48 heritage sites, 25 of which are open to the public. Thanks to FAI, these wonderful jewels now belong once again to Italy and to all of us.
